Job Description / Responsibilities

- Serve as an Empowered Official as defined by the International Traffic in Arms Regulations ("ITAR")
- Act as a Technology Control Officer, ensuring the company's compliance with the requirements of its Special Security Agreement
- Actively lead development and implementation of automation solutions across the export licensing, agreements, export and import clearance processes, and other trade compliance-related areas
- Support and manage the roll-out of the new company-wide ERP solution from a trade compliance perspective

- Lead the development of a new trade compliance training package for distribution across the company
- Provide primary ownership of the company's Denied Parties Screening processes
- Provide subject matter expertise in various relevant trade compliance laws and regulations, including the ITAR, Export Administration Regulations, Office of Foreign Asset Control Regulations, U.S. Customs Regulations, ATF Regulations and applicable foreign trade control regulations
- Work with internal program personnel to support and facilitate their international export/import needs
- Maintain records in accordance with applicable laws and regulations
- Actively participate in the company's internal trade compliance audit program
- Provide guidance and training to company personnel
- Other trade compliance-related duties, as assigned

Requirements

- A Bachelor's Degree and 5-10 years in trade compliance management or an equivalent combination of education and experience. Knowledge of various PC software applications is required. Ability to work independently, with minimal follow-up and guidance.
