In order to comply with Export Control Law, and requirements for Asia Pacific Dual Use Control, such as Singapore Strategic Goods (Control) Regulations and MOFCOM regulations, Veolia Water Technologies & Solutions Asia Pacific requires an Export Compliance Analyst to facilitate export control, export operation, & the license screening process.

The internal resource should have the ability to review transactions and understand the scope of products. The preferred function is Logistics.

Responsibilities

- Pull list of active parts and the designated HS codes imported/exported from Asia Pacific sites to support export control tagging review against the applicable dual use control list
- Coordinate with HQ ITC, Project Management & Product Specialists to review list of active parts
- Receive VWTS ITC Focal training & MOFCOM training
- Coordinate with third party agency on MOFCOM regulatory updates from the Unreliable Entity List and the MOFCOM list
- Perform thorough, accurate and documented compliance reviews of export shipments
- Deliver license management for the Asia Pacific sites and support the application of export control licenses, as needed, for items that trigger a local export license
- Responsible to improve non-standard and standard export documentation and compliance screening for the different sites based on local regulatory requirements
- Participation in import export community meetings and activities where required and support service provider management in assigned countries
- Support the export control tagging management system
- Maintain the Tagging application ("smart tagging") which supports the global business export control tagging process
- Execute reports from SAP to support tagging reviews and audits
- Identification & reporting of potential export control related process gaps and violations
- Help drive root cause analysis and corrective action identified during ITC audits
- Build an Internal Compliance Program process with product tagging and denied party screening for Asia Pacifica and & MOFCOM regulations

- Strong technical skills and experience with ECCN and HTS classification determination
- In-depth knowledge on import/export regulations and activities
- Prior experience with developing and implementing International Trade Compliance programs
